*** Note regarding Observations and Remarks Attached to Schedule IX (vide section 33&34 and Rule 19) for Financial Year 2019-20 ending as on 31st March 2020

- 1) Trust has opted to follow the presentation of Project Grant i.e. Earmarked Grant Funds to be routed through Income & Expenditure Account & Present the Grants received during the year as Income, Expenditure incurred out of Grants as expenses for the Object of the Trust. Un-utilised portion of current year Grant is shown as Surplus instead of Un-Utilised portion of the Grant.

Because of this, the surplus amount shown is really not Surplus but Un-utilised portion of Earmarked Project Grant. This way of presentation has been chosen by the trust based on the Expert's advice, handling FCRA matters.

- 2) Because of above mentioned method of presentation opted by the trust, the last year's Un-utilised balance of Project Grants has been shown as opening balance of Surplus of Income and Expenditure Account, to have proper presentation and consistency in Financial Statement i.e. Income and Expenditure Account and Balance Sheet of the Trust.

- 3) It is observed that because of some procedural lapses in filing of Income Tax Forms in addition to Income Tax Returns for earlier years, Income Tax Department has raised heavy Tax Demands on the trust.
Details of which are as under;

Trust has confirmed that they have taken up these matters through CA Firm and necessary submissions and follow up for getting the demand cancelled is in progress.

Trust is of the opinion that the demands are only because of procedural lapse which are normally closed after verification & proper compliance by the Income Tax Department.

2. The Activities of the Trust are;

Primary focus of SANGRAM is working with marginalized groups to prevent GBV and HIV and to provide care and support for group members who are in need. Activities are primarily built upon the concept of asserting rights and the core tenet that communities have the ability to find their own solutions. Principles include;

- Involving community members in program design, implementation, and leadership
- Creating a sense of community to facilitate collaboration, and
- Working to eliminate the stigma and discrimination associated with sex work.

SANGRAM has formed 5 collective of marginalized communities and a wide network of sex workers.

3. Foreign Contribution under Foreign Contribution Regulation Act (FCRA);

Trust is receiving specific grants i.e. Earmarked Grants from different Foreign Institution mainly American Jewish World Service (AJWS), Levi Strauss Foundation (LSF), Funds for Global Human Rights (FGHR) and others. 4. Local Activities;

In addition to FCRA Project grant activities, trust is also running different domestic activities mainly regarding Health and Welfare Schemes. Targeted Interventions for HIV Prevention, Care and Support, providing supplementary education classes and monitoring programs for which Earmarked Grants are received from different Government and other agencies such as National Rural Health Mission (NRHM) and Maharashtra State AIDS Control Society (MSACS).

5. Method of Accounting;

Method of accounting followed by the trust is cash system in respect of Grant Receipts i.e. the grant funds are accounted on the basis of actual receipts and expenses are booked in accounts when they are actually incurred i.e. either by the Trust or staff or other agencies. Expenses incurred are grouped as per the area of activity and the period involved for which grants are sanctioned. Because of these payments are not paid, those are reflected as payable to the staff in Balance Sheet.

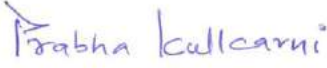

6. Presentation of Financial Statements;

a) FCRA- Foreign Contribution (FC) & Depreciation on FCRA Fixed Assets:

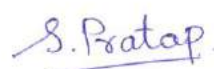
In case of foreign grants received during the year those are reflected in the Receipts and Payment account and as well as shown as Income in Income and Expenditure account even though the same is not an Income of the trust. This is mainly because, proper presentation of Foreign Contribution (FC) – Foreign project grants in the FCRA Statement and to comply with FCRA Rules and Regulations, as advised by expert on FCRA matters.

In FC Section all the Fixed Assets are out of the Foreign Grants because of this depreciation is calculated and reduced from cost of assets and the total amount is reduced from the Fixed Asset fund account reflected on the liability side of Balance

Sheet having equal balance of Fixed Asset on the Asset Side. Here the depreciation is not routed through Income and Expenditure Account as per the FCRA's presentation requirement and also confirmed by the trustees.

b) Domestic Grants Section;

In Receipt and Payment account total grants received and utilized during the year have been properly reflected. As these grants are with specific objects and directions for its utilization these are not the income of the trust. Board of Trustees of the Trust, based on advice of FCRA Consultant, has decided to follow similar Presentation of Local (Domestic) Project Grants i.e. Earmarked Funds, similar to FCRA.

Because of this the real income of the trust is not reflected, however once the same will be utilised then the same will be debited to Income & Expenditure Account resulting to total Utilization.

7. Endowment Funds;

During the year in FCRA Section the trust has transferred its Endowment fund amount of Rs.3,00,00,000/- (Rupees Three Crore only), which is the account for more than 15 years, has been transferred to Sangram Corpus Fund Account in FCRA Section only as approved by the Board of Trustees.

8. Related Party Disclosure;

Activities of the trust are conducted under the direct supervision of Trustees, Ms. Meena Saraswathi Seshu and Mrs. Shital Harish Pratap. Considering their direct involvement in the activities of trust, trustees have approved an Honorarium as under;

9. Income Tax assessment and demands;
